FROM THE EXECUTIVE DIRECTOR'S DESK

This year, Indian Social Institute completed 68 years of its existence, relentlessly engaging in socially relevant research, training, publication and advocacy through collaboration and networking with a large number of academicians, social activists, people's movements, human rights groups, civil society organizations and ecological movements throughout India and the world. Drawing inspiration from its founder, Fr. Jerome D'Souza SJ, who was a member of the Constituent Assembly, the Institute has been responding to the challenges faced by marginalised sections of society in the country by striving to make known the values and ideals of the Constitution of India among the masses with the hope that it becomes a lived reality for every citizen of our country.



The academic year 2018-19 has been full of activities with a focus on Dalits, Tribals, Women, and Peace building at the national and international level. The strategy has been to engage in conducting quality research, publication, training, seminars and various programmes. This year, we have increased our efforts to network and collaborate with a number of national and international institutions in our areas of expertise.

Research

In Dalit Studies, the Institute has continued to focus on the thrust area of "Discrimination and Exclusion in Education: A Study of Children of Communities engaged in 'Unclean" Occupations" across India. The Institute had already completed studies in Uttar Pradesh, Rajasthan, Himachal Pradesh, Haryana, Madhya Pradesh and Chhattisgarh in the last three years. This year, the Institute has completed similar studies in Bihar, Telangana, Andhra Pradesh, Karnataka and Tamil Nadu. The same study in the state of Jharkhand is in the final stages. As an outcome of these researches, a National Workshop was organised on "Looking towards Future: A Way Out for Communities Engaged in 'Unclean' Occupations" on 29-30 March, 2019. Based on all these studies, the Institute hopes to make a substantial contribution in policy making in the states and at the national level.

In the area of Tribal Studies, the Institute continued its focus on Tribal Development through its studies on "Implementation of Tribal Sub Plan (TSP)". Having completed the study in Jharkhand last year, the Institute completed the same study in Odisha this year and began similar studies in Madhya Pradesh and Chhattisgarh. Besides, the Institute also completed the socio-economic study of 39 villages in Dumka.

"Women at Work" continues to be the main thrust area of Women's Studies. In view of this, the study undertaken on "Women at Work in the Handloom Establishments in Uttar Pradesh" is progressing well after data collection. During the year, the study on "Dalit Women in Social Conflict: The Case of Haryana" has been completed and efforts are on to publish the study.

In addition, a new study on "Hygiene Management in India: A Women's Perspective" was undertaken and data has been collected from different locations in Delhi.

National Seminars

This year, three National Seminars were organised by the Institute. (1) A two day national seminar on "Labour Migration in the Post Liberalization Era" was held on 18-19 August, 2018, at ISI, Delhi. This seminar was jointly organised by Indian Social Institutes Delhi and Bangalore. There were 15 papers presented by research scholars, academicians and professors from different Universities, colleges and institutions, which has been published by Christian Institute for the Study of Religion and Society (CISRS) and ISPCK in the form of a book titled "Labour Migration in the Post Liberalization Era" edited by Denzil Fernandes and P.O. Martin. (2) A three-day National Seminar on "Women in Household Economy: Issues and Challenges Towards Gender Equality" was organised by Indian Social Institute on 11-13 October, 2018. There were 25 papers presented at the Seminar from research scholars, academicians and professors from various universities and institutions throughout the country. (3) A two day National Seminar on the "Contributions of Minorities to Nation Building" was held on 3-4 January, 2019, at Andhra Loyola College, Vijayawada. The seminar was jointly organised by Andhra Loyola College and Indian Social Institutes Delhi and Bangalore. Some of the papers presented during the Seminar has been published by Omega Book World and Indian Social Institute, Bangalore as a book titled "Minorities and Nation Building" edited by Selvaraj Arulnathan, S. Lourdunathan and Denzil Fernandes.

Peace Building

In the context of the rise in hate crimes and mob-lynching taking place in the country, Indian Social Institute has intensified its peace building work. (1) The Institute successfully completed the peace building project "Promoting Peace and Harmony Culture, Consciousness and Healing through Shanti Sadbhavna Manch among Students and Youth for Sustainable Peace, Justice and Harmony" supported by MISEREOR, where it organised several training programmes, Bal Mahotsavs, and other activities for 293 peace clubs established and maintained in schools and villages in seven states, namely Uttar Pradesh, Madhya Pradesh, Bihar, Jharkhand, Odisha, Chhattisgarh and Rajasthan. (2) An inter-religious conference on "Religion, Religions and Beyond: Different Perspectives" was jointly organised with Institute of Harmony and Peace Studies (IHPS) in the premises of ISI on 22nd September, 2019. (3) The documentary "Kandhamal Unresolved" by Shailendra Boora was screened on 16 October, 2018, in the premises of the Institute. (4) A National Colloquium on Peace and Reconciliation was held on 7-8 October, 2018, at the PG Block, Jnana Deepa Vidyapeeth, Pune. The colloquium was jointly organized by ISI and Lovola Institute of Peace and International Relations (LIPI), Kochi. (5) As part of a collaborative venture, ISI and LIPI conducted a certificate programme on Peace Studies in LIPI, Kochi from 16 March to 6 April, 2019.

Programmes

On the occasion of the 24th International Indigenous Day, the Institute organised a celebration on the theme "Celebrating Indigenous Cultures" at St. Xavier's School, Delhi, on 9th August, 2018. Over 2000 tribals from different parts of NCR Delhi participated in the programme. On

the previous day, the Institute joined other tribal associations in Delhi for a Press Conference at Constitutional Club to highlight issues of tribals in the country. During the year, the Institute also conducted Workshops on journalism as well as tribal rights, identity and culture in Delhi, Raipur and Sundergarh. They also organised consultations on tribal issues in Delhi, Jharkhand, Chhattisgarh and Odisha. Some of the consultations have been with the National Commission for Scheduled Tribes. Besides, a public lecture was organised on "Indian Music Tradition: Democracy and Film Music" by Prof. Mohammed Ashraf Aziz. In addition, a two-day workshop on "Legal Compliances for NGOs/Educational Institutions" was organised by the Institute on 27-28 October, 2018.

On the occasion of the 150th Birth Anniversary of Mahatma Gandhi, Indian Social Institute organised two programmes on the Gandhian theme of "Hind Swaraj". The first programme was the Seventh Paul de la Gueriviere Memorial Lecture, which was held on 1st February, 2019. The lecture on "Hind Swaraj: Then and Now" was delivered by Dr. Tridip Suhrud, an eminent political scientist and currently Professor and Director at the Centre for Environmental Planning and Technology (CEPT) University Archive, Ahmedabad. Dr. Neera Chandhoke, a retired professor from the Department of Political Science, University of Delhi, was the chairperson for the programme. The second programme was a two day workshop on "Hind Swaraj Today" by Dr. Tridip Suhrud on 2-3 February, 2019.

Legal Assistance and Training

This year, Indian Social Institute established the Centre for Human Rights and Law (CHRL), which has been providing legal assistance and training to NGOs, social activists and legal practitioners in different parts of India. During the year, a para-legal training was conducted in ISI, Delhi. In addition, workshops on "Empowering Women to Lead Change" and 'Educational Rights of Minorities' was conducted in the Institute. A Dalit Lawyers workshop was held in Jaipur and a consultation on the definition of minorities was held in the Institute in collaboration with Alliance Defending Freedom (ADF). The Institute has also provided legal aid and assistance to marginalised sections of society during the year.

Collaboration and Networking

Responding to the call of the 36th General Congregation of the Society of Jesus to undertake its mission through collaboration and networking with others, the Institute was engaged in several activities in collaboration with national and international organisations during this academic year. (1) ISI has been actively collaborating with Jesuits in Social Action (JESA) in the field of project management and financial management of project titled 'Lok Manch: Development and Access to Entitlements of the Marginalised', which has successfully completed its three year first phase and has begun the second phase. (2) ISI has been collaborating with the works of Jesuit Refugee Service (JRS) in the following ways: (i) Dr. Paul D'Souza provided professional guidance in the project on the "Impact Assessment of Jesuit Mission Outreach in Afghanistan"; (ii) ISI supported JRS in the successful completion of two phases of the Danish Refugee Council (DRC) funded project on "Mixed Migration Monitoring Mechanism Initiative". (3) ISI has been supporting the efforts of Delhi Minorities Commission (DMC) to help minority communities to access the welfare schemes of the Delhi Government. In this regard, ISI conducted three

programmes on awareness on minority welfare schemes and training in technical assistance for minorities. (4) ISI was part of a civil society initiative led by Wada Na Todo Abhiyan to evaluate four years (2014-18) of governance in the country and contributed two articles in the report titled "Promises and Reality". (5) Dr. Paul D'Souza was actively involved in the two day workshop organized on 11th and 12th March 2019 by the Gujarat Province Development Office, Ahmedabad, where he made a presentation on "The Nature and Structure of the SDGs" and presented a paper on "Faith-based Organizations and Development: Challenges and Opportunities in India and Gujarat".

International Engagements

ISI is part of the global research project on "The Future of Work, Labour after Laudato Si" involving 6 Research tracks on various issues on labour as part of the centenary celebration of International Labour Organization (ILO) in 2019. As part of the project, the staff of the Institute participated in three seminars. (1) International Seminar on "Work in the Ecological Transition" held on 19-20 June, 2018, at Centre Sèvres, Paris. (2) Research seminar on "The Future of Work, Labour after Laudato Si: Building Common Perspectives on Labour after Laudato Si" on 10-12 January, 2019, at the Dicastery for Promoting Integral Human Development, Palazzo San Calisto in Rome, and (3) International colloquium on "Climate Changes and the Future of Labor" on 24-25 January, 2019, at Centre Sèvres, Paris. As part of the project, the Institute contributed a paper in the book "Rethinking Labour: Ethical Reflections on the Future of Work" published by Caritas in Veritate Foundation as a working paper presented to the ILO on 7th November, 2018 in Geneva.

Dr. Paul D'Souza has been a member of the steering group of the international research network on "Keeping Faith in 2030: Religions and Sustainable Development Goals". As part of the network, he participated in the international workshop in Addis Ababa, Ethiopia on 15-23 September, 2018, and the SDG Conference in SOAS University, London, on 12-14 February, 2019. He is also part of the Research Team of the Geneva-based Jesuit Worldwide Learning (JWL) that has been committed to a robust research agenda to understand the individual, community, and societal impact of higher education at the margins.

Dr. Benjamin Bara attended the inauguration ceremony of International Year of Indigenous Languages on 28th January 2019 followed by its High Level Steering Committee meeting the next day at the UNESCO Headquarters, Paris.

Services Provided

Indian Social Institute has been supporting the initiatives of civil society groups in promoting democracy and social harmony in different parts of the country. The Institute has supported various organisations like CBCI, CISRS, AFPRO, World Vision, Caritas India and Jesus and Mary College by giving lectures and providing inputs on policy matters.

Indian Social Institute has attracted many visitors and interns from India and abroad. Students from Rokke High School, Japan, Don Bosco University Guwahati, Loyola College, Chennai, and North East Institute of Social Science & Research, Dimapur, Nagaland visited us during the year. In addition, 25 interns worked for about one or two months in the Institute during

the year. They belonged to Jawaharlal Nehru University, Jamia Millia Islamia University, Ambedkar University, Delhi University, Fairfield Institute of Management and Technology, Jiwaji University, Gwalior, National Institute of Technology, Rourkela, Tata Institute of Social Sciences (TISS), Mumbai and Salesian University, Rome.

The support services of Indian Social Institute include Documentation, Library, Publication, Finance and Administration. The Documentation section has a good collection of articles and data published in journals, newspapers and various electronic media on socially relevant topics, which is disseminated to NGOs, academicians, social activists and students. The library has a collection of about 34,000 books on social sciences, which is computerised and available online. In addition, the library subscribes to over 150 national and international journals. The Publication Department publishes books and booklets which are popular among students, social activists, NGOs and academicians at Book Fairs. This year, the Institute participated in two Book Fairs in Delhi and Lucknow. The Institute published five books, two of them have been in collaboration with Gyan Publishing House. The Administration section provides secretarial assistance, maintenance, computer and internet services, and other administrative services. The finance department supports the Institute through its financial management, providing financial services and constantly updating the Institute's financial practices due to changing tax laws. In particular, the finance staff did a commendable job in responding to queries from the Income Tax Department.

The Staff

They also authored 7 articles in edited books, 4 articles in peer reviewed journals and 28 articles in newspapers and print or online magazines in India and abroad. Besides, they presented 30 papers or lectures at Seminars, Conferences and programmes organised in India and abroad. Some academic staff are editors of journals and magazines, such as *Social Action, Legal News and Views* and *Hashiye Ki Awaz*. The staff of the Institute were invited by television channels CCRTV, NDTV and India Today to be on their programmes. There have been regular sharing of activities among staff and a Staff Development Programme was also organised. Staff Family Day was held on 22nd December, 2018 and Staff picnic to the Pratapgarh Farm was organised on 22nd February, 2019.

Indian Social Institute was given an award for exemplary service to minorities by the Delhi Minorities Commission (DMC) at its annual Conference held on 17th December, 2018, in Vigyan Bhavan, Delhi. The Institute remains a beacon of hope to marginalised communities suffering from socio-economic inequalities and growing religious fundamentalism by the services rendered in terms of research, training, publication and programmes. The Institute hopes to contribute positively to the national and global effort to build a world that is sustainable and equitable in collaboration with civil society, people's movements and academicians worldwide.

DALIT STUDIES



A. Introduction

Indian Social Institute has been engaged in research on Dalit issues as a major thrust area through the activities of the Department of Dalit Studies (DDS). The Department designs and implements research initiatives into conditions of Dalits in partnership with academic institutions and grassroot community organizations, publications, networking and advocacy interventions, aimed at Development of Dalit communities, by giving voice to their struggles for rights and contributing to the policy making. Over the years, the Institute has been fulfilling its mission to be at the forefront of the struggle for the rights of the marginalized groups in India by engaging in research on issues related to Scheduled Caste communities, conducting Seminars, workshops and training programmes for social organizations as well as grassroot social activists.

Over the last few years, the Department is intensely investigating into exclusion and discrimination of Dalit communities engaged in "Unclean" occupations through a mega project on "Discrimination and Exclusion in Education: A Study of the Children of Communities engaged in "Unclean" occupations across India in twelve states, i.e. Uttar Pradesh, Rajasthan, Himachal Pradesh, Haryana, Madhya Pradesh, Chhattisgarh, Bihar, Jharkhand, Tamil Nadu, Karnataka, Andhra Pradesh and Telangana. The Institute hopes to make a substantial contribution to most vulnerable communities leading to policy changes.

B. Research Projects

B.1. Completed Projects

Discrimination and Exclusion in Education: A Study of the Children of Communities Engaged in Unclean Occupations" – Bihar, Karnataka, Tamil Nadu, Andhra Pradesh and Telangana.

This research was undertaken to gather empirical evidence of discrimination in education and their causes and consequences on the attainment of education of the children, especially of those belonging to the households



associated with "Unclean" occupations in urban India. The study focuses to identify the processes of exclusion and discriminatory practices meted out on the children in schools from the households associated with "Unclean" occupations and how they influence their lived experiences of education. The study looked at their educational status, reason for such status, what is the situation at school, measures initiated by the governments, the impact of such discrimination, and finally the study proposes a list of recommendations to policy makers. A comparative analysis of disparities and similarities in the states is aimed at to promote a comprehensive policy by the state and central governments.



Corroborating empirical data from the selected states suggest that association of households with "Unclean" occupations reinforce the poor quality of accessibility, availability, acceptability and adaptability effecting educational status of the children of the households. The multiple dimensions of exclusion in education, both within the educational institutions and outside the educational system create lasting negative impacts on children, not only in the academic domain - the performance in the school but also in personal domain - psychological life as a person. The



immediate and long term impacts of discrimination and exclusion of children of communities engaged in "Unclean" occupations are visible among children which were identified and observed during qualitative investigation in the selected cities, such as lower self-esteem and self-worth. self-denial among children, lower levels of interest and motivation in studies, poor performance, high rate of absenteeism and discontinuation of studies, and low aspirational levels to pursue higher studies.

Thus, an assessment of the educational status of the children forces us to look beyond just quantitative aspects of exclusion and discrimination to the qualitative dimensions operative within and outside the educational system. Both, the instrumental as well as structural dimension within and outside educational system are crucial in generating and sustaining social exclusion, therefore need to be attended at an equal footing for better future for the children of marginalised communities in India. Further, the study has made some important observations and presented practical recommendations which if utilized by the State and Policy Makers would bring drastic change in the life of the students belonging to the household associated with "Unclean" occupations.

B.2. On-going Projects

As mentioned above "the Discrimination and Exclusion in Education: A Study of the Children of Communities Engaged in "Unclean" Occupations in the state of Jharkhand" is in progress.





C. Seminars/Workshops/Training

i) "Looking towards future: A Way out for the Communities Engaged in "Unclean" Occupations"

Department of Dalit Studies organized a two-day national workshop "Looking towards future: A Way out for the Communities Engaged in "Unclean" Occupations" on 29th& 30th March 2019. A total of forty participants were present in this workshop from over ten states of Delhi, Haryana, Uttar Pradesh, Bihar, Madhya Pradesh, Chhattisgarh, Gujarat, Andhra Pradesh, Tamil Nadu and Karnataka. The workshop had two-panel discussions followed by question-answer session and sharing of state representative perspectives.

The workshop began with a presentation "Discrimination and Exclusion in Education: A study of the children of communities of "Unclean" occupations" by Dr. Ratnesh Katulkar. This was followed

by a panel discussion on the theme "Education (formal, technical vocational) as a way out for occupational mobility of the communities engaged in "unclean" occupations. The panel included Ms. Annie Namala, Executive Director, Centre for Social Equity and Inclusion, New Delhi; Mr. Martin Macwan Executive Director, Navsarjan Trust, Ahmedabad; and Prof. N. Sukumar of University of Delhi.



In the evening session, the state representatives from Uttar Pradesh, Haryana, Karnataka, Madhya Pradesh and Chhattisgarh, along with Ms. Rehana Mansoori of Dalit Foundation, Urai, Uttar Pradesh, shared their experiences with the community, and their approach and efforts for the way out for the communities traditionally engaged in "Unclean" occupations.





On the second day of the workshop, the day began with a session on sharing by the state representatives from Bihar, Gujarat and Tamil Nadu. This was followed by a panel discussion chaired by Dr. Teena Anil, Assistant Professor, Ambedkar University, New Delhi (AUD). The panelists were Mr. Wilson Bezwada, Executive Director, Safai Karmachari Andolan, Ms. Amrita Gupta, Director of Research, Advocacy & Communication, Azad Foundation and Mr. Karandeep Bhagat, Senior Coordinator, Centre for Social Equity and Inclusion, New Delhi.

In the concluding session, Dr. Paul D'Souza animated the discussion on the way forward and Mr. Shabih Anwer presented the major issues that emerged during the discussions at the workshop. During the discussions that followed many suggestions were made for the way forward such as promoting innovation and use of technology for cleaning jobs, good governance for abolition of untouchability, and building leadership at the state and national level.

TRIBAL STUDIES

A. Introduction

Over the years, the Department of Tribal Studies in Indian Social Institute, New Delhi has been a ray of hope for the tribal communities living across the country. It has constantly engaged with the target groups in empowering them through research, training, advocacy, publications and consultations. The department has played a proactive role in supporting the marginalized, voiceless and the vulnerable. In recent years the tribal studies have mainly focused on tribal development, wellbeing, tribal self-rule, tribal women's issues, tribal domestic workers, together with the responding to the emerging challenges and concerns like the recent Supreme Court's judgement of February 13, 2019 on the Forest Rights Act and proposed amendment to the Indian Forest Act 1927 etc.

The present engagement in research especially in the area of tribal development and tribal self-rule under the Tribal Sub-Plan is a major undertaking of the department. This study is opening many avenues for more deeper and long term engagement with the idea of development as such and tribal development in particular. Other activities, like consultations, trainings and workshops are means of educating the tribal masses for empowerment for active participation in development processes and implementation of tribal self-assertion and self-rule. The present report card of Department of Tribal Studies is a record of our engagement for a period of one year.



B. Research Projects

B.1. Completed

Evaluation study of the "Implementation of Tribal Sub-Plan (TSP) in Odisha"



A research was conducted to study the impact of TSP and map the beneficiaries getting benefits from the TSP schemes. The study concludes, although there are various provisions for better and proper mechanisms for adequate allocation of funds for the scheme, it has never been realized ever since its inception. The allocation has always been low and even to the extent of half of the proportion. There has also been some satisfaction as far as Special Central Assistance (SCA) and a provision under Art.275 (1) is concerned. However, for last few years it has been declining, particularly in case of SCA. As far as the

implementation is concerned, it seems that the plan is well formulated and well-designed but the implementation and achieving the desired result has been far from reality. The study suggests a proper implementation and careful monitoring of the plan and active community participation requires from the very inception of the plan, its implementation, execution and evaluation.



Socio-Economic Study in Dumka

A survey of 38 villages surrounding Dumka town was carried out in collaboration with four other partner organizations of Dumka to study about the 'Zonal Development Project', a Master Plan prepared by the Department of Urban Development, Government of Jharkhand. All together 1,811 households were surveyed for this study. Out of which 1,485 (81.9%) belong to Schedule Tribe (STs), 45 (2.48%) households belong to Schedule Castes (SCs), while 277 (15.29%) households were from Other Backward Castes (OBC), and 04 (0.22%) from General category. The study shockingly revealed that only 12 (0.66%) out of the total respondents were consulted during "preparation of the master plan." 1,719 (94.91%) out of the total respondents were not





in the favour of this new proposed development plan. Moreover, 1,632 (90.11%) of the total respondents are not aware about the government's compensation in lieu of the per acre land acquisition. The study shows that the master plan for Dumkazonal development project was prepared unilaterally by the government where the villages and communities affected by this development plan were kept in dark. Such development plans without peoples' participation, who would be actual beneficiaries or victims of the plan, shows shredded face of development. The actual plan for development of a city, state or country is measured by people's participation in the entire process of development. Every plan for development needs people's participation. Any plan attempted without people being partners in the process is a development in vacuum. The town of Dumka in Jharkhand is a standing example.

B.2. Ongoing

B.2.1. Evaluation study of the "Implementation of Tribal Sub-Plan (TSP) in Chhattisgarh"

A research project is going on the assessment and impact of TSP in Chhattisgarh. Government

has implemented various schemes in the tribal areas for the socio-economic upliftment of the tribals. The study is being conduct in the four districts of Chhattisgarh i.e. Kabirdham, Dhamtari, Sukma and Rajnandgaon. At least three blocks in each district have been studied. After getting the list of the beneficiaries through the Right to Information (RTI) (list from Nagri block in Dhamtari district is still awaited), a field survey was done and data was collected through interview schedule from the respective places. Presently data entry is over and the analysis is going on.



B.2.2. Evaluation study of the "Implementation of Tribal Sub-Plan (TSP) in Madhya Pradesh"

This research study is similar to the TSP project going on in Chhattisgarh. This study is at its initial stage. RTI has been filed in the districts and very few responses have been received. Follow up on those responses are going on. Rest are still awaited. After receiving the data through RTI, field survey will be conducted for data collection. Analysis of data will be done and research findings along with suggestions will be published. The objective of this research project would be to disseminate information through seminars and workshops on the implementation of Tribal Sub Plan in the



tribal dominated area and to do advocacy to the government for policy intervention.

C. Training Programmes/Workshops/Consultation

C.1. International Indigenous Day Celebration

24th International Day of the World's Indigenous Peoples was celebrated at Millennium Hall of St. Xavier School, Raj NiwasMarg, Delhi. More than 2000 Indigenous/Tribals/Adivasis living in Delhi-NCR including youths, children, parents and relatives attended this program. The local theme of the celebration was "Celebrating Indigenous Cultures" and the international theme of 2018 was "Indigenous Peoples' Migration and Movement." The objectives of the celebration were:

- **⊃** To bring the uniqueness of different Indigenous cultures on one platform.
- → To bring awareness among the Adivasis/Tribals in Delhi about constitutional provisions, Indigenous rights, cultures, customs and practices.
- **⊃** To bring awareness about the struggles, injustices and violations of the Indigenous rights and work towards their solution.





This was a collaborative effort of Indian Social Institute, New Delhi, Delhi Adivasi Youth Network and All Adivasis Delhi-NCR. The aim of this celebration was to unite tribals in Delhi and to collect different tribal communities under one platform. There were many programs that were put by various tribal groups of Delhi. Dances from Munda, Kharia, Santal and Oraon community were main attractions. Youth including students from Vidyajyoti College of Theology had put up a street play based on the current issues of forest, land and water resources in tribal areas. Youth from Delhi also performed instrumental music songs which were very entertaining. The special attraction of the program was 'Adivasi Fancy Dress Competition' which was for the children. Young tribal budding entrepreneurs had also put their stalls of Indigenous T-Shirt, artifacts, Tribal clock, garments and so on. Indian Social Institute had also put stall of books and publications outside the hall for sale. Chief guest Ms. Collet Rahmi Kujur, a Judge in Karkarduma Civil Court and various guests of honour were called from different states like Jharkhand, Chhattisgarh, Odisha, and Madhya Pradesh.

D. Advocacy/Networking/Consultation

DTS has been actively engaged throughout the year in consultations and coordination with various NGOs, social workers and institutions. These are as follows:

- 1. Visit to Tea factory run by Catholic diocese of Tezpur to understand how the socio-economic upliftment of tribals could be done by having a tea factory in collaboration with local tribals owning tea gardens.
- 2. A one day meeting was organized by the village committee of Kutra block, in Rajgangpur Odisha where DTS representative gave training to the villagers on tribal rights, constitutional rights, and legal rights. That was to empower and build capacity of the villagers.
- 3. Collaborated with Jivan Vikas Maitri, Pathalgaon, Chhattisgarh to give awareness on tribal and constitutional rights. The aim of that program was to equip local tribals with their rights.
- 4. Conducted a one-day consultation and training with the Diocese of Raigarh for the catholic priests and nuns on the tribal rights and formulation of strategy for the upcoming elections.
- 5. Consulted National Commission of Schedule Tribes on various cases like the land acquisition by the Odisha Cement Ltd. near Rourkela, arrest of villagers in Khunti districts on Pathalgadi cases, misuse of reservations etc. Based on the consultation a public hearing was also organized in Ranchi to review the petitions and legal cases on tribals in Jharkhand.
- 6. Consultation with Ministry of Environment Forest and Climate Change on the issue of Forest Rights Act and recent amendments on Indian Forest Act 1927, in the month of February and March. The whole idea was to seek help and guidance to formulate strategies to counter these issues.
- 7. Providing periodic expert consultation to Dr. Shanta Kerketta, Lady Irwin College on Sustainable Renewable Energy. This is progressing ahead in the form of project proposal for installation of solar water pump in the rural areas of Jharkhand and Chhattisgarh.
- 8. Giving consultation to CBCI on developing business model for rural areas on agriculture, Food Processing and small business projects for sustainable economic development.
- 9. Coordinating with CBCI to develop a national website for the tribals that could have pan-India reach. The aim of this website would be to provide latest information and updates related to tribal issues and concerns.
- 10. Dr. Benjamin prepared write upon Forest Rights Act 2006, recent issues and way forward and presented in a workshop organised by DTS in ISI.

WOMEN'S STUDIES

A. Introduction

Department of Women's Studies functions at three integrated levels, including acquiring knowledge as an outcome of its research works; disseminating knowledge through publications; and activating women for social transformation through training and advocacy efforts. The programmes are mainly action-oriented, aiming to counteract adverse effects on oppressed population from varied persisting and emerging forces and to do this logically analytical evaluation is conducted based on facts and figures in regard to effects of various forces on this marginalized section. The department contributes towards gender equality through research, training, publication, conducting national and international seminars, workshops, collaborating with organizations and conducting sessions on gender issues both within and outside the Institute. It analyzes and supports human, social, cultural and economic development towards gender equity and social justice. Committed to the mission of sensitizing the mass to assert and recognize the potential and capabilities of the women and make the women themselves realize and assert their capacities and skills and mainstream their needs, concerns, demands and move towards gender equality. It envisages major initiatives in research, training and advocacy in the areas of gender and women's studies.



B. RESEARCH PROJECTS

B.1. Completed

B.1.1. Dalit Women in Social Conflict: The Case of Haryana



The main purpose of this field level qualitative study in Hisar and Gurugram was to investigate the consequences and factors that lead to Dalit women bearing the brunt of social conflict in rural Haryana by being easy targets of violence and find out the conflict management mechanism adopted by Dalit women in rural Haryana. Also tries to analyze role of state & non-state actors & of different stakeholders in protection of Dalit women's rights in rural Haryana. This project work

and its qualitative data collection at field level in Hisar and Gurugram, was done in terms of causes; consequences; role of state/non-state actors. Besides this worked on literature review; prepared points for questionnaire; prepared questions for the interview; worked on research methodology chapter; networking with NGOs to get assistance regarding field investigators and local contacts at field level for the project in Gurgaon district and Hisar district of Haryana. Was involved in field-visits to conduct Case Studies and FGDs, as pilot study, in Gurgaon district to examine how social conflict issues affects Dalit Women in rural communities of Haryana. In the field village meetings were conducted, data collection was done in identified villages, and also conducted interviews with stakeholders.

B.2. Ongoing

B.2.1. Women at Work in Handloom-Handicraft Establishments in Uttar Pradesh

The study attempts to understand the critical issues in the handloom and handicraft sectors and discussing both favorable and unfavorable conditions of women weavers in the handloom sector. The study explores to what extent post-liberalization expansion of markets and change in governance structure have impacted on the conditions of women weavers. Initiated work plan on this research study with wider discussions on the research program on Women at Work been worked-out for three-five years



across sectors. Designed the context, rationale, aim, and objectives of the study. Designed and finalized the conceptual and analytical framework for the study and finalised its research design in terms of Sustainable Development Goals in the intended study, that is, Goal 5 and Goal 8, that is, Decent work, Gender Equality and Labour Standards. Issues for discussion as well as tools were finalised for collecting required information during the intended visits.

Preliminary visit to Lucknow was materialised in November, 2018. Final data collection was initiated in December, 2018 in its rural and urban areas. Conducted Focus Group Discussions, and visited intended stakeholders, including Handicraft Division, production Centre, pockets of chikankari workers. Interaction and meetings were also held with both handloom and handicraft workers in International Surajkund Fair, Faridabad at field level in February, 2019.

B.2.2. Hygiene Management in India: A Women's Perspective

Menstruation is a natural process linked to the reproductive cycle of women and girls. If not properly managed it can result in health problems which can be compounded by social, cultural and religious practices. With absence of basic facilities like water, women toilets etc., in rural India, women tend to compromise on their hygiene management. This study is an effort to understand the impact of poor sanitation on the safety, wellbeing, and educational prospects of women.



C. SEMINAR/WORKSHOP/PROGRAMMES

C.1. National Seminar on Women in Household Economy: Issues and Challenges Towards Gender Equality





Gender equality means that women and men enjoy similar conditions and opportunities to fully exercise their potential to contribute to development, and benefit from the results of such development. The unequal division of labor by sex is the factor behind much of the discrimination against women. Indeed men and women are both different but they can make positive contributions to the economy. Women are more likely than men to work as unpaid family labourers or in the informal sector. This seminar dwelt upon the multiple linkages between unpaid work and the conventional macro economy that would make it necessary to expand the boundary of conventional macro-economic so as to incorporate unpaid work.

This three-days National Seminar, "Women in Household Economy: Issues and Challenges Towards Gender Equality" on October 11-13, 2018 highlighted on the need for a change of values and behaviour in the society, a need for positive socio-cultural and economic empowerment and above all the determination of women themselves.

LEGAL AWARENESS & TRAINING

The legal awareness and training programme under taken by the Department of CHRL is aimed at empowering, enlightening and equipping in particular the target groups towards transformation, sustainable growth and development. The following training programmes conducted during the year were well appreciated by the participants and it also helped strengthening our existing network with various civil society organizations and individuals.

Increasing legal literacy and legal awareness about their rights can empower citizens to lead a dignified life as guaranteed under the Constitution of India. In line with the same which is well reflected in the vision of the institute also, the above training programmes are conducted, in particular, to educate the weaker sections of the society about their rights, duties and privileges enshrined under various social welfare legislations and other enactments. The CHRL team played a significant role in their efforts to legally empower the last and the least of the society on various laws including the Constitution of India, basic legal concepts in civil and criminal law with special emphasis on law relating women, Schedules Castes and Scheduled Tribes. children, minorities etc. Apart from the class room lectures by legal luminaries



and experts in law, exposures to various judicial and quasi-judicial forums also played a big role for better legal education and capacity building of the participants. Beneficiaries of these training programme often tell us that the training programme have helped them to get engaged constructively with the government and access their basic rights and entitlements effectively.

PEACE BUILDING

Title of the Project: "Promoting Peace and Harmony Culture, Consciousness and Healing through Shanti-SadbhavnaManch (Peace and Harmony Students and youth movement) through capacity building among the most marginalized and excluded, anchored in institutions and communities in 8 States"



Nonflict and violence leave behind ∠individual and structural wounds. It can permeate memory and get passed down for generations, getting woven into personal and cultural narratives and creates a distorted relationships and often results in revenge, hatred and violence. The Peace Building (Shanti-Sadbhavna) Project is a conscious process under taken by the institute towards building peace and bringing social healing. It is possible to carve out models of peace and Shanti-Sadbhavna is one such model whereby volunteers for peace through the active guidance and support of CHRL team strive to create an atmosphere of living not only "side by side" but "with" each other in serenity, peace and harmony accepting one another as equal other. In order to achieve this purpose, Peace Clubs are established in selected villages and schools and the members of these clubs are motivated and enabled to engage in peace building activities and dialogue.

The project is carried out in 7 States (Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Odisha, Rajasthan and Uttar Pradesh). It was a 3 year project and was supposed to end by 30th June 2018. However, in the first year of the project, we faced several problems in its implementation in various villages and schools of these States and so our request to the funding agency to

extend the project for one more year was responded positively but without any financial support from the agency. Towards the end of the Project, an evaluation of the project was conducted with the help of an external expert, Mr. Joseph James.

The evaluator very strongly felt that the project has significantly addressed the objectives set for the project in most



appropriate manner. These objectives have significant relevance in today's context where conflict is prevailing in every aspect of life. The report also emphasized that sensitizing local youth and leaders on issues of conflict, training them to analyze the context of conflict in more scientific manner and then mobilizing them into collective forces has tremendous potential to address rights and conflict issues in the most appropriate way. Various success stories from the field on our efforts to establish peace and resolve conflicts also talked in volumes. The participatory approach involving youth, children, local leaders, teachers, local administration and police in building peace was also highly appreciated. Due to the positive outcomes of the project, our request for extending the project was approved by the funding agency and is extended up to 31st December 2019.



The seminar was jointly organised by Andhra Loyola College, Vijaywada, and Indian Social Institutes Delhi and Bangalore. The Seminar began with a welcome address by Dr. G.A.P. Kishore, Principal of Andhra Loyola College, who stressed on the need to highlight the contributions of minorities in the country. Rev. Joseph Raja Rao, Bishop of Vijaywada, in his

inaugural address pointed out to the many contributions made by Christians for the welfare of the citizens of India. Dr. Irfan Engineer, in his keynote address, stressed on the composite and syncretic culture of India, where all sections of society including minorities worked together right from the Independence struggle to all sectors of the economy today. During the course of the two-day seminar, twenty two papers were presented by various academicians, research scholars and professors in colleges and universities all over India on the various contributions of minorities in India.

An inter-religious conference on "Religion, Religions and Beyond: Different Perspectives" was jointly organised with Institute of Harmony and Peace Studies (IHPS) in the premises of ISI on 22nd September, 2019. The keynote address was delivered by Dr. Amitabh Kundu. Other speakers at the Conference were Dr. M.P. Raju, Prof. Arvinder Ansari, Prof. M. H. Qureshi and Dr. M.D. Thomas. About 60 delegates participated in the conference.

IsI has been actively collaborating with Jesuits in Social Action (JESA) in the project titled 'Lok Manch: **Development and Access** to Entitlements of the Marginalised' by being part of the Core Team, assisting in the external evaluation of Lok Manch, participating in Workshops and assisting in the preparation of the next phase of the project. The first phase



of the project was successfully completed on 31 October, 2018 and the second phase of the 3 year project began on 1 November, 2018.




Is I has been supporting the efforts of Delhi Minorities Commission (DMC) to help minority communities to access the welfare schemes of the Delhi Government. In this regard, ISI conducted the following programmes:

- 1. Programme on "Training and Technical Assistance to Minorities" for the advisory members of DMC was held on 21 January, 2019, in the premises of the Institute. 88 advisory members of DMC participated in the programme.
- 2. Awareness programme on Scheme "Reimbursement of Tuition Fee for Students belonging to SC/ST/OBC/Minority Category" was held on 26 January, 2019, at Loyola Vocational Institution, Rohini. 80 parents of Christian, Muslim, SC, ST and OBC communities from different sectors of Rohini Area participated in the programme.

3. "Awareness Camp on Minority Welfare Schemes for Communities" was held on 20 March, 2019, in Fr. Agnel High School, Gautam Nagar. About 150 parents of children belonging to minority communities participated in the programme.

Tndian Social Institute was part Lof a civil society initiative to evaluate the last four years (2014-18) of governance in the country. 
iii. Hashiye Ki Awaz

The collected documents and information are updated and uploaded in the website regularly and people from all over the world are making use of this documented information. A huge collection of archives, of more than a decade uploaded on the website for easy reference for the users. The data/information on various topics is also made available through e-mail on request.

E. Legal Aid



In the words of Justice P.N Bhagwati, "Legal Aid means providing an arrangement in the society so that the mission of administration of justice becomes easily accessible and is not out of reach of those who have to resort to it for enforcement... the poor and illiterate should be able to approach the courts, and their ignorance and poverty should not be an impediment in the way of their obtaining justice from the courts." Resonating with the invitation underlined in the above words and keeping in line with the vision and mission of the institute, it was felt that we need to set up a mechanism to help the poor and the needy who are unable to afford legal representation and access to the Court

system. We were also requested by individuals, NGOs, Civil Society Organizations and even the beneficiaries of our trainings for starting a legal cell for getting legal aid and support. Thus the birthing of Centre for Human Rights and Law (CHRL) took place in January 2019.

Until December 2018, neither the institute had a separate legal cell nor was the Training Unit, which is now re-named as involved in any direct and regular litigation. The main activities of the Training Unit was involvement in the human rights related issues and dissemination of

legal literacy and awareness mainly through various legal trainings, publication and various advocacy works.

At present CHRL team consist of three advocates namely adv. Fr. Joy Karayampuram, Adv. Ravi Sagar and Adv. Tresa Paul besides other supporting staff. Besides all our activities such as trainings, publication etc, we are involved in regular litigation although our focus is out-of-court settlement. We have been involved in many issues and getting favourable orders in matters relating to minorities, family matters, Dalit issues, criminal matters etc. People contact us directly in our office and indirectly through phone and social media and we provide them legal consultation on various issues relating to family, marriage, property, minority, consumers, SC/ST, labour and other various issues.

SERVICES PROVIDED

A. LIBRARY

A.1. The library Section

The library named after Fidel Rosl Goetz is being developed with specialized resources catering to the needs of the marginalized groups (Dalits, Tribals, and Human Rights etc.). The library has stock of computer bibliographic database of print books as well as a small collection of rare and reference books on social science. The library is computerized, and has evolved into a fully automated library environment with the support of Koha Online library software and special URL.

During this financial year 135 new books have been added in library database and received more than 700 books on donation from Library of Apostolic Nunciature in India. More than 249 books out of donated were found suitable for our library. Library is subscribing 14 regular national newspapers, Both English (09) and Hindi (05).

A.2. Online Service:

The Library online catalogue provides excellent services to search the different titles of development issues. During the period from April 2018 to March 2019, the catalogue was searched 10856 records from ISI database as well as outside Library Users. Library has online facility to access statistical data from CENSUS, articles from EPW & SAGE journals.



A.3. Membership & Borrowing:

16 New members have joined the library and 123 individual users and 183 group users (13 Groups) have visited the library this year. Under borrowing 572 books and 21 research reports were issued to them. Inter library loan has given to NPC, NUEPA & NCAER during the financial year.

A.4. Journal Section:

The journal section of the department received 160 periodical both National and International. Of these, subscribed journal 108, obtained on exchange basis 20 and on gratis 43. The library also subscribes 9 journals in Hindi. 290 Special articles downloaded from various sources. 991 articles were indexed from journals and magazines and distributed to stakeholders. The display of all the journals in the in-house reference and reading room is an additional attraction for the users. The



relevant back –volumes journals are bound and kept in the library for researchers and library users. The service has given to our collaborator, Jesuits social centre and updating researchers with latest articles & new arrivals for easy reference.

B. Publications

During these book fairs, thousands of people visited the stall and appreciated the subjects we choose for publication. Legal Education Series both in Hindi and English are very much appreciated and pointed out that these kind of low priced legal books are not available anywhere in India. All those who visited the stall of the Institute in these book fairs invariably picked up at least one or two booklets saying that the institute is doing a good work for the common people. These legal literacy booklets have been becoming more essential, and there is a good demand in

the market as well as numerous schools, colleges and universities.

Impact Assessment of Jesuit Mission Outreach in Afghanistan

The Assessment of JRS interventions in Afghanistan was undertaken by JRS South Asia in collaboration with Indian Social Institute with following major objectives.

- To help in documenting the shared mission journey, and in piecing together a comprehensive picture of how various interventions have contributed to achieve JRS vision, goals and priorities over the past 12 years in Afghanistan's socio-political context.

- To help increase participation of the local communities JRS serves, to strengthen ownership of the interventions, and prepare local communities to move towards more a sustainable future.
- To understand possible socio-economic and educational ramifications of JRS interventions in Afghanistan, and thus make needed course corrections to discern and plan well for the journey that lies ahead.

The final draft of the impact assessment report was submitted to the Governing body of the institute on 29 March 2019.

D. Conference and Residence Facilities


D.1. Conference Unit

To improve our facilities, we started to give more basic facilities like towel, bath soaps, mosquito repellents, packed drinking water once at welcome etc. We are trying to provide maximum help and support to our customers and becoming more customers friendly.

SUPPORT SERVICE SECTION

A. Administrative, Finance and Support Service

The Department of Administration (DA) comprises of General Administration (GA), Computer Section and office of the Executive Director (EDO).



The Office of the Executive Director operates in compliance with its duly adopted Bylaws, Policies, and Operating Rules for overall growth of the Institute and to achieve the vision and mission of the Institute. The ED office has been developing and implementing a fundraising plan; writes grant applications; furnishing granting agencies with required progress reports of the various projects undertaken by the Institute. It is establishing, managing

and administering the Institute's financial resources to ensure

sound financial health of the Institute is maintained and sustained. Every department was asked to discuss and prepare annual budget for the following year, along with programmes, research, training, maintenance etc. The final proposed budget was presented to the Governing Body for their perusal and approval. Besides the above, the ED office takes care of all official records, documentation of official matters, public relations and contacts on behalf of the Institute.



The General Administration takes care of the reception at the Institute, the nitty-gritty



of administrative details, leave, travel booking, contact with government offices and public utility services; the computer section provides support service to all the departments; The maintenance staffs take care of the cleanliness and hygiene of the Institute. The computer section takes care of the technical aspects.

The Finance Department plays a supportive role in achieving the vision and mission of the Institute. The Institute has down the years developed finance management policy, transparent procedures, and periodic monitoring mechanisms so that financial health of the Institute is maintained and sustained. The Institute also regularly updates itself and the staff on changing income tax rules and related laws so that every staff and the Institute strictly adhere to the laws of the land.



The Institute believes that financial audit and transparency in financial matter increases the motivation and commitment of the staff. As per the practice of the Institute, the department carried out half yearly audit and also periodically distributing the budget realization statements to all the departments. Moreover, interim budget review was organised by the Institute. This helped every department to understand how the resources has been utilised till then and also to make a strategic financial plan for the following months.

Each head of account is allotted code number while preparing annual budget. This has resulted in accuracy and bringing more clarity to review the money allotted and actually utilized under each head. The finance department senior staff also gave lectures on legal compliance such as TDS, FCRA, Income Tax, GST etc. related to NGOs and Educational Institutions. It has also provided the necessary support to various departments in the budget preparation. This was a big learning exercise for the staff. The Finance Department also complied with filing of GST return, TDS return, FCRA return, Provident Fund return and other financial reports both manually and online within the stipulated time. It also prepares and obtains utilization certificates in order to submit them with the Funding Agencies and various Government Departments for the grants received and utilised.

INDIAN SOCIAL INSTITUTE NEW DELHI

A Brief History:

The Indian Social Institute was founded, more than a centre of research, as an ideology to contribute to the task of social transformation. At the time of founding of the Institute, the then General of the Society of Jesus stated "the Institute should be founded for the serious study of the Indian social situation in all its aspects". Adhering to this mandate the Institute has been ever in search of new ways of engaging in social transformation according to the signs of the times.

The Institute began its journey as 'Indian Institute of Social Order' in January 1951 in Pune in response to the challenges of nation-building and emerging new social order in the post-independent era. In 1958, the Institute was registered in Pune as Indian Social Institute. Realising the importance of being present in the national political capital, in 1961the Institute was shifted to New Delhi and a new entity was registered under Xavier Institute of Social Order. However, later in 1969 the Institute was registered as 'Indian Social Institute'.

In the first decade, till 1960s, the focus was on spreading social doctrine of the Church; in the following decade the Institute expanded its scope to accompany NGOs and focused on training, thus giving birth to Indian Social Institute, Bangalore. The third decade was marked with sensitivity to women's issues and establishment of Mobile Orientation Team (MOT). In the 80s, the fourth decade, it made a definitive choice to align with people's movements and accompany them. As the government opened itself in



1989 to Thatcher-Reagan neo-liberal philosophy the Institute responded to the challenges of liberalization, privatization and globalisation (LPG). In the same decade the Institute adopted rights-based perspective as a cross-cutting subject permeating all the endeavours of the Institute which continues till today. In the new millennium, expanding civil society space and advocacy works have assumed greater significance aimed at policy changes. The Institute enjoys the status of an NGO with special consultation status with the Economic and Social Council of the United Nations.

All through these years the Institute has enjoyed great credibility among the academicians, activists, students, and marginalized communities through varied interventions like, action-based research, publications, capacity building programmes, and policy interventions through advocacy works. It has also provided space for like-minded persons and organisations to come together, reflect and respond with appropriate strategies. During this long journey many persons have contributed to the nurturing of its growth and also have taken shelter under the shades of its wings. The management and staff of the Institute earnestly hope that the Institute will grow further in the years to come to spread its fragrance far and wide.

Vision: To build a just, humane, secular, democratic and inclusive Indian society wherein the poor and marginalized communities cherish equality, dignity, freedom, justice, peace and harmony.

Mission: To engage in social transformation through socially relevant research, training, publication and advocacy works aimed at integral development of the marginalized communities, particularly the Dalits, Adivasis/tribals, women, minorities, unorganized and landless labourers in partnership with academicians, people's movements, human rights organizations and ecological movements nationally and internationally.

Approach: The approach is both pedagogic and programmatic. It is pedagogic in the sense that our actions are aimed at creating critical consciousness, through action-reflection process, and eventually structural change in the system. It is programmatic in the sense that it is through different and concrete programmes that we try to achieve this structural change, knowing that, "For a successful revolution (transformation) it is not enough that there is discontent. What is required is a profound and thorough conviction of the justice, necessity and importance of political and social rights" (B. R. Ambedkar), and having the conviction that, "A small body of determined spirits fired by an unquenchable faith in their mission can alter the course of history" (Mahatma Gandhi).

STRATEGIES

1. Action Research:

Over the years, there has been a concerted effort to combine activism and academic research, taking cognizance of the prevailing tension and conflict at many levels. This effort has brought activists and academicians together to promote substantive research, combined with meaningful activism, trying to bridge the gap between theory and practice. To effectively engage in research and expand knowledge base and analytical perspectives, the Institute collaborates with universities, academicians, research scholars from different disciplines and activists. Every research is planned to be taken to its logical end resulting in capacity building, publication and

advocacy works.

2. Capacity Building:

Years of experience have enabled the Institute to engage in trainings, workshops and seminars as an integral part of its strategy, largely as outcome of researches of the institution. On specialized themes, issues and developmental concepts the Institute also organizes capacity building programmes. Each department is engaged in a focused and systematic manner capacity building of the priority groups at various levels, including issues related to policy interventions. To progressively realize alliance of the marginalized inter-departmental capacity building programmes are planned and implemented. The Department of Human Rights and Law promotes legal literacy among the NGOs, leaders of people's movements and priority communities with training and legal series booklets in English and Hindi. Capacity building of urban poor was recently added as a new interventional space of the Institute. To impart social research skills and techniques the Institute conducts a course on Research Methodology as part of its core activity every year.

3. Advocacy:

Networking, campaign and advocacy are part of the modus operandi of the Institute, to protect, promote and progressively realise the human rights of the marginalized and vulnerable communities through interventional mechanisms. The Institute joins hands with grassroots organizations, people's movements, NGOs, advocates, networks, civil society organizations and national and international organizations in advocating people's rights to live a humane and dignified life. In order to intervene at the systems level and to exert pressure on the corridors of power, the Institute is in live contact with bureaucrats, government officials, decision- makers, elected representatives, ministers and national commissions and institutions.

4. Publication:

The primary responsibility of the Publication Department is to publish books, reports, documents and compendiums prepared by the staff of the Institute and by others who write on themes compatible with the objectives of the Institute at an affordable cost and makes them available for the non-profit sector and civil society organizations. The Institute to its credit disseminates three journals: Social Action as a quarterly journal and Legal News and Views and HashiyekiAwaz as monthly magazines. All journals and magazines have ISSN code. Subalterns is a quarterly news bulletin of the Institute where current affairs are reflected from the perspective of the marginalised, along with ongoing engagements of the departments and news about the Institute. All these journals, magazines and newsletter are designed and marketed by the Publication Department.

5. Documentation and Library:

With the sudden surge of Information and Communication Technology (ICT), apart from maintaining a well catalogued library, this department gathers and disseminates information/data through documentation, pertaining to the priority communities through print and electronic media. It has also started a Human Rights News Bulletin, which is flashed to hundreds of recipients. A number of research scholars, activists, university students and administrators visit our library and some are members of the library too. The library has been computerized and automated to make it user-friendly.
